# ABSTRACTS FOR POSTERS DEADLINE IS 1ST MAY!

#### **Abstract submission**

- 1. The work to be presented must be ORIGINAL and not previously accepted or submitted elsewhere for presentation or publication.
- 2. Abstracts must be sent by email to <a href="https://hrwm.capetown@ntlworld.com">hrwm.capetown@ntlworld.com</a>
- 3. Receipt of all abstracts will be acknowledged.

- 4. The text of the abstract should not exceed one thousand words.
- 5. Up to 2 figures or 2 tables may be included with the abstract *only if they give information that will influence the selection process*
- Abstracts of investigations that will not have been substantially completed by the receipt of abstract deadline for ORAL presentations will only be considered as POSTER presentations.
- 7. Deadline for receipt of abstracts to be considered for POSTER presentation is **1 May 2003**
- 8. Abstracts received after the POSTER deadline may not be considered.
- The decision of the Programme Committee in selecting papers for inclusion in either the ORAL or POSTER sessions is final and no discussion will be entered into.
- 10. Successful applicants will be invited to submit manuscripts of their papers. Details on manuscript preparation will be made available. Manuscript receipt deadline is 31 July 2003 late manuscripts will not be returned to authors.

Water Safety: Risk Management Strategies for Drinking Water International Conference in Berlin, Germany, 28-30 April 2003

#### What is it about?

The WHO Guidelines for Drinking-water Quality are following a new approach: their central element is to improve "process control" through introducing risk assessment and quality management. This is termed "Water Safety Plan" and uses key elements of HACCP. This stands for Hazard Analysis and Critical Control Points, and is familiar from food industry, where it has proven very successful. - Experience with application of this approach in drinking-water is available from Switzerland, France, Australia and Uganda.

#### Why is an opinion on HACCP important for the drinking-water sector?

The international discussion of the benefits of applying the HACCP approach to drinking-water systems is rapidly gaining momentum. The systematic approach to assessment, control and monitoring is increasingly perceived as advantageous, as this allows flexible systems tailored to the specific setting. Past experience indicates that an impact of the WHO Guidelines for Drinking-water Quality on the next revision of the EU Drinking-water directive is likely.

- How does this new approach relate to existing regulations?
- How is it different from quality management systems currently applied to drinking-water supplies?
- What would its introduction change for suppliers and for public surveillance?
- What does the drinking-water sector think about this development?

- Development of the WHO Guidelines for Drinking-water Quality
- Development of the EU Drinking-water directive
